We would like to inform you that, on December 8, 2025, the Bochum Local Court — Insolvency Court — ordered preliminary insolvency proceedings against the assets of innolectric AG.

The court appointed

Ms. Dorothee Madsen, an attorney from the BRL BOEGE ROHDE LÜBBEHUESEN law firm, as the provisional insolvency administrator. A copy of the court order is attached to this letter.

The Management Board will actively support the process alongside the provisional insolvency administrator.

With the support of our business partners, we are confident that we will succeed in achieving a sustainable restructuring of innolectric AG. For you, the most important thing is that business operations will continue as usual, and the proceedings will aim to ensure innolectric AG's long-term survival as the best possible outcome for creditors.

Currently, there is only one change for you: the insolvency court has authorized the provisional insolvency administrator to collect claims from innolectric AG. Please transfer your liabilities to the following account in the future:
